**Question#1:**

Annex A of the Solicitation, 5.2.1.1.e) states to "Ensure that IM's are covered by appropriate insurance, including Workers Compensation Board coverage and appropriate liability insurance (see Annex F - Insurance Requirements)"

I applied to the Workers Compensation Board to get coverage and was told that we don't need the coverage, as Indigenous Monitoring is exempt from WCB coverage. Do you require us to still obtain the coverage for the RFP? Please advise.
