This Request for Proposal (RFP) amendment is issued to respond to Questions (Q) 10 to 16, with the following Answers (A) and make 2 RFP change:

Bidder's Questions

Q10:

Laboratory Testing

Can you specify how many firearms have to be sent for laboratory testing?

A10:

Part 6, Para 6.17.2 does not obligate laboratory testing. However, the weapons must already be conformed to the requirements stated in Annex B, Para. 2.3.5 – Weapon Conventions.

Q11:

Flash Suppressor:

Can you provide technical specifications of the visual signature required for the flash suppressor?

A11:

The flash suppressor should provide a 95 percent flash reduction threshold.

Q12:

Range:

What type of testing is expected to be performed?

A12:

Annex A, Sub-para 2.5.4 (b) (X) (6) does not specify if the values provided must be determined through experimentation or theoretical calculation.

Q13:

Front sight type:

Is there a specific type of Front Sight profile being sought?

A13:

No.

Q14:

Definitions – Ambidextrous:

Can you please clarify what is the definition of reconfiguration in the scope of this RFP?

A14:

Please see update to Annex B, Para. 1.4

Q15:

Concealability:

Will the removal of the stock requiring the use of a tool be allowed?

A15:

Annex B, Para. 2.4.3 does not prohibit the use of a tool to remove the stock.

Q16:

Controls:

Does the changing of the Charging Handle have to be performed without disassembly?

A16:

The changing of the charging handle can be done during the disassembly of the weapon.

RFP Changes

Annex B, para 1.4 is amended as follows:

Delete:

Ambidextrous	Capability of a shooter firing left or right handed to safely operate the switch or control without reconfiguration of the weapon, and with the shooting hand safely holding the trigger grip ready to fire.

Insert:

Ambidextrous	Capability of a shooter firing left or right handed to safely operate the switch or control without reconfiguration of the weapon to either a left-handed configuration or right-handed configuration, or changing any parts, and with the shooting hand safely holding the trigger grip ready to fire.

Annex B, para 2.4.3 is amended as follows:

Delete:

“The PDW must be provided with a removable stock. Removal of the stock requiring replacement with a provided base plate is permitted. The replacement base plate must be provided with the PDW.”

Insert:

“The PDW must be provided with a removable stock. Removal and replacement of the stock with the use of hand tools is permitted. All special tools required to remove and replace the stock must be provided with the PDW. Removal of the stock requiring replacement with a provided base plate is permitted. The replacement base plate must be provided with the PDW.”

ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED.
