REQUEST FOR PROPOSAL AMENDMENT 006

This Amendment is raised to publish questions and answers

QUESTION AND ANSWERS- SERIES IIII

- Q.15 Further to the answer to question Q7 in Amendment 04 - What is the useful information that PSPC is trying to identify in this table? We note it is worth 50 points, so we want focus attention in the correct place. Would it be possible to partly fill out the form, that would demonstrate its utility. Perhaps PSPC would consider allowing the consultants to provide alternate formats that are not strictly tied to the weeks of the calendar, but more to the activities and sub activities and real hours associated, relative to the phases of the project.
- A.15 We are seeking to evaluate the proponent's understanding and demonstration of the level of effort for each resource over the duration of the project. It is not necessary to provide the quantity of hours, only percentage utilization is being requested. Partly completed examples are provided in Appendix G, and additional rows can be added for sub-activities.
- Q.16 Further to the answer to question Q9 in Amendment 04 – Is it possible that there is a team that has done the precursor studies for this project, that will be bidding on the project, and knows this budget information? A ballpark estimate is essential for the rest of us. A project budget of \$10M, \$100M, \$500M, or \$1 billion would imply a significantly different level of effort (and fee) to do a study such as the one requested in the RFP. It is essential that all the bidding teams have an understanding of a ballpark budget +/- 50M to be able to fairly provide a fee.
- A.16 An estimated project budget will not be provided. Proponents can infer the scale of the project based on the background information and descriptions that have been provided in the Project Brief / Terms of Reference.
