The purpose of amendment number 007 is to respond to vendors' questions and amend the Solicitation Closing Date.

Question 1:

Upon review of the Objective of Solicitation No. 47419-206529/A it appears that category P5 Project Executive roles and responsibilities fall well outside the Scope of the objective to: "augment capacity in the planning and execution of departmental IM/IT initiatives managed by the Information, Science and Technology Branch (ISTB) team on an as and when required basis." Specifically, augmenting capacity of established IT projects that are being managed by ISTB does not require a Project Executive and in effect precludes a Project Executive from being on the team. The inclusion of this senior executive role will likely disqualify a number of Aboriginal SMEs that otherwise have extensive experience successfully providing IM/IT consultants in order to augment capacity in IM/IT initiatives.

We respectfully request that the Crown remove the Project Executive requirement and position entirely from this Request for Proposal in order to allow more Aboriginal IT/IM suppliers to submit compliant proposals.

Response 1:

Canada has considered your request. However, the resource category "P.5 Project Executive – Level 3" will remain in this requirement.
