SOLICITATION AMENDMENT 001 TO SOLICITATION W847A-200271/A

This Solicitation Amendment (001) is raised to correct the following from the original solicitation.

Delete paragraph 1.1 and replace with the following:

1.1 Statement of Work

The Canadian Armed Forces (CAF) under the Fixed-Wing Search & Rescue Aircraft Replacement Project (FWSAR) will require accommodations, amenities and laundry services in Seville, Spain for the planned period of 30 August 2019 to 01 April 2020. Up to forty (40) personnel will require Hotel Services for the duration of the training. This requirement is estimated between 4300 and 5500 room nights.

More details are provided in the Statement of Work – Annex A.

Delete paragraph 4.2 and replace with the following:

4.2 Basis of Selection

A bid must comply with all requirements of the bid solicitation to be declared responsive. **The responsive bid with the lowest total estimated value (in Annex B- Basis of Payment) will be recommended for award of contract.**

Award priority will be given to full bids, then partial bids.

A full bid is considered if all requested guestrooms are provided under one (1) hotel or one (1) apartment complex.

Bids that propose multiple properties will be considered as partial bids. In this case, each property will be evaluated individually.

Should there be no full bids, partial bids will be accepted. However, such bids must offer a minimum of fifty (50) percent of guestrooms on all nights.

Multiple contracts may be awarded if there are no full bids.

The required amount of guestrooms are estimates and could vary throughout the duration of the contract.
