Amendment 002 has been raised to answer questions from potential bidders.

**Q1. Re: 3.1.2 Licensing, Certification or Authorization**

The Proponent shall be authorized to provide Architectural and Engineering services and **must include an architect licensed**, or eligible to be licensed, certified or otherwise authorized to provide the necessary professional services to the full extent that may be required by provincial or territorial law in the province of British Columbia, and the Yukon Territory. If the Proponent is licensed to practice in only one of the two jurisdictions, then that Proponent must be eligible and willing to be licensed in the jurisdiction in which they are not licensed.

The proponent must provide the **AIBC number** of the Senior Personnel.

*Failure by the proponent to provide the required evidence or in the event that the evidence cannot be verified shall result in the Proponent being disqualified and no further consideration being given to the Proponent.*

You must indicate **current license** or how you intend to meet the provincial and territorial licensing requirements.

Is the highlighted requirement "must include an architect licensed" also interchangeable with "engineer" or intended to be "**architect** and **engineer** licensed," as the part "authorized to provide **Architectural** and **Engineering** services" would suggest?

A1. Most of the time, the firm will be providing assessment services as well as full architectural services for the remediation of the building envelope issues. It includes producing architectural drawings for submissions for permits and the subsequent contract administration services. Therefore the requirement for an architect is to fulfill requirements similar to the above.

Q2. In addition could the proponent be an engineering firm practicing in building envelope services within the limits of part 5 of the code, include an architect as a sub-consultant to the team should the scope extend beyond part 5 to include architectural scope, either as one of the senior or project personnel or as a separate sub-consultant?

A2. An architect is required as a senior personnel or joint venture and not as a sub-consultant.

Q3. In Amendment No. 001, you indicate that a licensed architect is required. However in BC, building envelope rehabilitation work is typically conducted by Professional Engineers under Bulletin 34 (attached, see highlighted text on p.2 and various other pages). This Bulletin is nearly 20 years old, and in practice most consulting work on existing buildings in BC are performed by P.Eng's.

We agree though that on new construction an architect is required, and the building envelope consultant is often a P.Eng. working with that architect.

We have no registered architects on staff, only architectural graduates. If we were to pursue this standing offer, we would have to team up with an architectural firm.

Can you confirm that our understanding is correct?

A3. An architect is required as a senior personnel or joint venture and not as a sub-consultant to provide full architectural services upon initial assessments for contract document, permit submissions and contract administration.
