The Solicitation Amendment 002 is raised in regards to the following:

1. To provide the answers to the bidders questions.

Question 1:

Can you please advise if the customer can provide an extension of 3 weeks in order for us to get the testing completed by an independent third-party laboratory as per their requirement?

Answer 1:

The test reports are required after bid closing upon request of the Contracting Authority. The timeframe to submit the test reports is 28 calendar days upon request. This is sufficient time to get the testing done and therefore no extension will be granted.

Question 2:

Please advise if you can provide a list of third-party accredited laboratories that are capable of testing in accordance with the RCMP's test method for the test Reports.

Answer 2:

We cannot provide an exhaustive list of accredited laboratories. The choice of third party accredited laboratory for testing is at the bidder's discretion. Any accredited laboratory familiar with mechanical testing should have the equipment and capability necessary to conduct testing in accordance with the test method.

All other terms and conditions remain the same.

A bid already submitted may be amended prior to RFP closing time by sending the amended correspondence to Bid Receiving Unit, the envelope/message bearing the PWGSC file number and the most current closing date.
