Answer 13:

Suppliers are requested to cross-reference their demonstrated experience in the ITQ response documents to the corresponding mandatory requirement. The use of a table of contents is not required, but may be used at the supplier's discretion.

Question 14:

Can you clarify in Annex 6, Form 2 Project Reference Check Form, Question (f). What does affiliation mean?

Answer 14:

In this context, affiliation means the corporate legal relationship between the Supplier (or Joint Venture member) and the Client Organization and Customer Reference. For example, where the Client Organization is itself an affiliate of or other entity that does not deal at arm's length with the Supplier, the two entities would be considered as "affiliated" for the purpose of completing Annex 6 Form 2 - Project Reference Check Form.

Question 15:

How can more information be added to Annex 6, Form 2 Project Reference Check Form? The sections are limited to single lines with limited space as to how the supplier meets the requirements. There is also no section for dates of when services were provided.

Answer 15:

A Microsoft Word version of Form 2: Project Reference Check Form is provided to suppliers as an attachment to this Amendment 005, and may be used by Suppliers to submit each customer reference relative to each project in response to a corresponding mandatory requirement(s) in Annex 2 - Mandatory Evaluation Criteria. Suppliers may add information via the word attachment version or provide the additional information on a separate document.
