Q032: For clarification, can you please confirm that all yard work on spec item 12.1 - Starboard Main Engine #4 Removal and Replacement - will be covered on the \$50,000.00 allowance that came out on amendment 009? If not, can you please clearly identify what work items are intended to be priced separately from this allowance?

A032: Amendment 009 is applicable to the scope of work described in Sections 12.1.C.55 to 12.1.C.103 where the work associated with #4 Engine requires direct assistance to Wartsila FSR. All sections outside indicated 12.1.C.55 to 12.1.C.103 within whole Section 12.1 must be priced separately from allowance.
