Response 1:

No, however the final size has been revised to 5-3/8" x 8-1/2"

The specification of the Annex "A" Statement of Work has been revised to reflect a final booklet size of 5-3/8" x 8-1/2" as the only acceptable size for the finished booklet. The final files that will be provided to the Contractor after contract award reflect a booklet of these dimensions (5-3/8" x 8-1/2").

Question 2:

Can the initial delivery date be changed from July 17, 2019 to a later date?

Response 2:

The delivery date has been revised to reflect a delivery date of "no later than July 30, 2019.
