STATEMENT OF WORK

Repairs to Veterans' Grave Markers

24 Cemeteries – Sydney Area, Nova Scotia

Introduction

Veterans Affairs Canada requires repairs to 736 Veterans' Grave Markers in 24 cemeteries.

Background

Veterans Affairs Canada (VAC) is responsible for the care and maintenance of approximately 220,000 Veterans' graves and grave markers across Canada.

Objective

The objective of this project is to obtain cemetery maintenance to Veterans' Grave Markers.

Scope of Work

Tasks/Requirements

The contractor must perform the following tasks:

1. Contractor will be required to provide all labour, material and equipment necessary for the supply, delivery, and installation of the following deliverables:

3. All work must be completed in accordance with Section 4 and Section 5 of the Veterans Affairs Canada National Technical Maintenance Manual (attached as Appendices A and Appendices B) and each cemeteries terms and conditions.
 - a. It is the responsibility of the contractor to make themselves aware of the cemeteries terms and conditions.
4. Complete any landscaping required to bring the site to its original state. Any required sod or seeding must be completed at each new or repaired marker.
5. Provide photographs of all new and repaired markers as per specifications contained in Annex C. NOTE: All photographs must be submitted on an SD memory card mailed to the Project Authority.
 - a. Every marker which maintenance has been completed must be photographed.
 - b. All photographs must be submitted on the camera's SD memory card to the Project Authority.
 - c. Pictures will include both the marker and foundation and should be taken so that the marker and foundation fill approximately 75% of the frame.
 - d. Any photograph that is not taken correctly must be redone at the expense of the contractor.
 - e. Annex C contains additional instruction and hints for ensuring that photographs are acceptable.
 - f. There is no requirement for photographs of markers prior to work being completed.

Constraints

1. Work will cease if in the immediate vicinity of a funeral until the conclusion of the service.
2. No work is allowed to begin on Saturdays that cannot be finished by 12:00 PM that day. This includes the removal of litter and debris.
3. No work is permitted on any Sunday.
4. No work is permitted on any Statutory holiday. It is the responsibility of the contractor to be aware of the statutory holidays.
5. No material and/or equipment can be left onsite overnight at any grave marker.

Compliance Requirements

The contractors personnel are required to adhere to the terms and conditions of each cemetery. It is the responsibility of the contractor to make themselves aware of the cemeteries terms and conditions.
