Amendment 011 is raised to address Bidders questions:

Q033: Based on discussion with an International FSR we don't feel that the SP10 is achievable with the current coating system on the underwater hull. We ask that the surface area that we are bidding on is to apply to areas where Inerta 160 is not present underneath the current PPG Amercoat coating?

A033: The underwater hull is entirely coated with Americoat with the possible exception of the sections trapped between the ship and the blocks. If the ship doesn't quite sit on the blocks in the same way as previous and there are sections of intact Inerta 160 that need to be removed, we can adjust the cost accordingly.

Q034: Reference Manual mentioned in 17.1.B is missing, can you please provide?

A034: Canada does not believe that the manual is needed for an estimate, the description of the work should be sufficient.
