SOLICITATION AMENDMENT NO. 002

As some resources may no longer have a copy of their degree / diploma, and receiving a copy from any institution will take many weeks, could the Crown please confirm that degree confirmation from the institution will be accepted as proof?

Response 22:

As per section 3.2 (iv) (B) of the RFP, with regards to educational requirements, a copy of the results should be included with the bid and, if it is not, it should be provided, during the evaluation period, upon request, within 2 working days. As such, a degree confirmation from the institution is not sufficient.

As written, to score full points resources need 84 months of experience within the last 84 months. This is unreasonable, as it excludes any candidate that has ever gone on short-term disability, had to take leave for a personal or family emergency, or taken bereavement leave. Many of the most qualified resources in the NCR have had to deal with such tragedies in their 20+ year careers, and this does not make their experience any less relevant to what the Crown requires. As such, we respectfully request that the Crown amend the requirement to state:

"The proposed resource should demonstrate a minimum of 60 months of combined experience within the last 120 months, at the time of bid closing, in each of the following 7 categories..."
