The Solicitation Amendment 003 is raised in regards to the following:

1. The closing date of July 4th, 2019 is postponed to July 11, 2019.
2. To provide the answers to the bidders questions.

Question 1:

In Ref: Annex B, Para 4.2.9 Marking

Would it be acceptable to have the RCMP Stock Number and Date of manufacturer information on the packaging of the Baton Holder using a label?

Answer 1:

For the marking requirements outlined in para. 4.2.9 of the Purchase Description, a label on the baton holder packaging will be acceptable. The Purchase Description will be amended to reflect the change to marking requirements at contract award.

Question 2:

Can you please clarify with the customer again as to why they would not allow for the largest of the 3 baton holders designed specifically for the largest baton they are currently using to not weigh 3 grams more than what they are requesting? We are again requesting that the weight requirement for the largest baton holder be changed to a maximum of 107 g in weight.

Answer 2:

A maximum weight of 107 g for the 26" baton holder will be accepted. Para. 4.2.8 of the Purchase Description will be amended at contract award to reflect the increased allowance in weight.

All other terms and conditions remain the same.
