## **Logistics Vehicle Modernization (LVM) Project – List of Qualified Suppliers**

On April 26, 2019 Canada published the Invitation to Qualify (ITQ) W847L-190122/B as the first phase of the procurement process for the Logistics Vehicle Modernization (LVM) Project. Respondents were invited to pre-qualify in order to participate in any subsequent phases of the procurement process including the Review and Refine Requirements (RRR) Phase. Interested suppliers were informed that only Qualified Suppliers would be permitted to participate and bid on any subsequent solicitation issued as part of the procurement process.
