REQUEST FOR INFORMATION (RFI)

FOR: GCSurplus, Public Services and Procurement Canada (PSPC)

PSPC is exploring new ways to communicate with Government of Canada registered charitable organizations and is seeking to collect information about their material needs to provide important insights to Government of Canada donations of surplus moveable assets.

PSPC is seeking the following information from charitable organizations across Canada who are interested in potentially receiving donations:

1. What types of items are you interested in receiving? For example:
 - Entertainment items
 - Games and toys
 - Clothing, footwear, outerwear
 - Outdoor equipment
 - Household items
 - Furniture
2. Would donated items received be resold or donated again by your organization?
3. What communities or individuals does your organization serve and benefit?
4. Can your organization assume responsibilities related to pick-up and transportation for donations?
5. Does your organization have the capacity to provide auditable records on donations made by your organization?

This is not a bid solicitation.

This Request for Information (RFI) will not result in the award of any contract. This RFI will not result in the creation of any source list; therefore, whether or not any potential organization responds to this RFI, it will not preclude that organization from participating in any future donation.

This RFI is simply intended to solicit feedback from registered charitable organizations. The information obtained pursuant to this RFI may or may not be used in an Invitation to Qualify (ITQ) at a future date.

The Government of Canada will not reimburse any respondent for any expenses incurred in responding to this RFI.
