C) QUESTIONS AND ANSWERS

Q1 Who will be supplying the timber for the fence?

A1 The contractor will need to provide the timber for the fencing and the timber for the stairs. These are both separate items in the payment procedures. These are also listed as separate items under site furnishings in the unit price schedule. See SITE FURNISHINGS specification Section 32 33 00 for item #2.1 and item #2.2 for more information.

Q2 Please confirm the clearing and grubbing items required for this site, as there seems to be multiple items listed for undergrowth clearing listed.

A2 See PAYMENT PROCEDURES specification Section 01 29 00 under section #1.3 Unit Price Items item #.4. Clearing and Grubbing – Expanded Campsite Areas, Roadways and Boat Launch Area (Section 31 11 00) and item #.5. Clearing and Grubbing – Grubbing Isolated Trees Stumps (Section 31 11 00). The Unit Price Schedule lists both of these items separately under the unit price schedule.
