A. STANDING OFFER

7.9 Financial Limitation

DELETE:

The total cost to Canada resulting from call ups against the Standing Offer must not exceed the sum of ~~\$250,000.00~~ (Applicable Taxes excluded) unless otherwise authorized in writing by the Standing Offer Authority. The Offeror must not perform any work or services or supply any articles in response to call ups which would cause the total cost to Canada to exceed the said sum, unless an increase is so authorized.

INSERT:

The total cost to Canada resulting from call ups against the Standing Offer must not exceed the sum of **\$150,000.00** (Applicable Taxes excluded) unless otherwise authorized in writing by the Standing Offer Authority. The Offeror must not perform any work or services or supply any articles in response to call ups which would cause the total cost to Canada to exceed the said sum, unless an increase is so authorized.

PART 2 – 2.4 ENQUIRIES - REQUEST FOR STANDING OFFERS

To ensure consistency and quality of information provided to bidders, significant enquiries received and the replies to such enquiries will be provided simultaneously to bidders to which the bid solicitation has been sent, without revealing the sources of the enquiries.

Here are the questions which we have received until now:

Question #2: Would Canada agree to amend Annex B to include a guaranteed minimum per month to cover fixed costs?

Answer #2: Canada refuses to amend the Basis of Payment in Annex B as suggested in Question # 2. The objective of a standing offer is essentially based on the principle that no commitment is made to commit to specific quantities (or in this case minimum quantity) during the call for tenders, but instead, provide estimated quantities that represent the approximate volume of consumption for the contract period specified in the Request for Standing Offer.

Question #3: If Canada does not accept the Question # 2 proposal, could it consider another form of pricing to ensure a minimum monthly contract for the selected contractor?

Answer #3: Canada refuses to modify the Basis of Payment in Annex B as suggested in Question # 3. As mentioned in Annex B - Basis of Payment under point 2, firm unit prices and firm hourly rates in Table B.1 are lump sum prices, i.e. the contractor agrees to perform the work for that stated cost, regardless of whether it results in a loss or a profit.
