AMENDMENT 001

The Solicitation Amendment is raised to provide answers to questions raised by bidders as follows:

Question 1

Can we offer multiple options in the bids (one would be exactly of same quality as described in the tender document, the other would be a better version in terms of quality). Perhaps detailing both in either same bid, or separate bids?

Answer 1

You can offer multiple options, however you must provide a separate bid for each option. Bidder must ensure that the substitute product has the same properties as specified in Annex A under Technical Requirement.

Question 2

If we source Item 1 and Item 2 (sheepskin and hide) from Douglass Interiors (the supplier listed in the tender document) do we still need to conduct separate flammability/airworthiness tests than the ones provided to us by Douglass Interior?

Answer 2

If the test match with the batch that will be delivered, no.

Question 3

In regard to lab test for items 1, 2, and 3, if we already have certification of airworthiness and flammability, do we need to get new test results for the samples, or can we use preexisting ones

Answer 3

If the sample match the same lot than the material delivered and certification are specific to this lot, yes, you can use pre-existing ones.

Question 4

For the flammability test report needed in the sampling process. Is there limitations on the location for the testing facility? For example, Chinese or U.S. laboratories.

Answer 4

Test laboratory must be approved in Canada or USA.

Question 5

Would you please inform us the Pantone color of Silver Grey Sheepskin Hide, Leather Hide and Velvet Carpet?

Question 6

Please let me know the dimensions of required sample for Substitute Products?
