2. Provide answers to questions raised by a potential offeror.

Q1 (E) To submit an offer, must it be done in person? Or via un courier service?

A1 (E) Offers must be submitted only to PWGSC Bid Receiving Unit. Offers can be submitted via facsimile, in person, by using Canada post e-post connect, by courier service (Purolator, FedEx, etc.) Offers must be received by the date, time and place indicated in the RFSO.

Q2 (E) For special order products, pricing is based on cost and not on a retail price. We can't commit to a specific discount % because prices are established from cost when the product is bought.

A2 (E) If no discount is indicated Canada will take for granted the discount % is 0%. In Annex "D" – Financial Evaluation, the Product category for Special Orders is not evaluated.

Q3 (E) If we are unable to bid on certain regions, is it acceptable to not submit a price for those regions?

A3 (E) The Offeror may submit an Offer for one region or multiple regions. See Part 3 – Offer Preparation Instructions, article 3.1. That being said, for the region you are submitting an offer, you must be able to serve all the institutions within that region and also submit a price for all the items of the category for which you're submitting a price.

Q4 (E) Given the vacation period, will it be possible to have an extension of bid closing date?

A4 (E) No.
