2. Questions and Answers 1 through 3:

Question 1:

Does the first aid training equipment need to be removed from the facility each night of the course, or can it be stored on site until the end of the class?

Answer1:

Yes. The contractor should plan to remove training equipment each night. However at time of booking a training session, the contractor can verify with the institutional site regarding the ability to leave materials overnight.

Question 2:

For the medium and maximum-security facilities, will there be a correctional officer present throughout the training?

Answer 2:

No. Contractors must obtain Reliability security status and will be provided an orientation to the site. This will allow them to work unsupervised at the site. See Statement of Work Sections 3(e) and 8 and Annex C.

Question 3:

Is there an opportunity to run 8-hour classes at the medium and maximum-security facilities so the training can be completed in 2 days instead of 4-days?

Answer 3:

No. However, at time of booking a course, the contractor and site can discuss to determine if alternate hours are possible. See Statement of Work Section 6.
