SOLICITATION AMENDMENT NO. 001

This amendment 001 is to answer questions and amend the RFP accordingly.

QUESTIONS AND ANSWERS:

Question 001: Could you please confirm whether there has been any contractors or incumbents that have provided these or similar services within the past 12 months? If so, what was the value of the contract and the name of the company that provided those services?

Answer 001: As indicated in the Notice of Proposed Procurement (NPP), the work being requested under this solicitation reflects a combination of both new and previous requirements. There is currently no incumbent performing ALL the services of this requirement however SOME of the tasks are currently being performed by Valcom Consulting Group as part of a contract valued at \$3,264,423.00.

Question 002: Can you confirm that resources working at:

- CFS Matsqui, BC will be reporting for work at Canada's offices in Abbotsford, BC?
- CFS Riverbend, AB will be reporting for work at Canada's offices in Edmonton, AB?
- Point Petre, ON will be reporting for work at Canada's offices in Trenton, ON?"

Answer 002: The municipalities specified in section 1.2 of the RFP are reflective of the geographical area (within 10-50 km of the DND installations) where work will be performed. The offices where resources will be required to report to will be specified in the individual Task Authorizations.

Question 003: The extract on Buy and Sell states that, "**The work under this solicitation is a combination of both new and previous requirements. There is currently no incumbent performing all the services of this requirement.**"

- Of the sites identified in in the solicitation, which sites are considered new?
- Of those new sites, how are they currently being serviced?
- If those new sites are in fact being serviced internally, what has been the level of effort?
- Of those sites considered as previous requirements, what was the past or current levels of effort by site location?

Answer 003: The work represented by this requirement are a collection of both new and existing tasks at Canadian Forces various installations across Canada. Some of the individual tasks that will be asked of the individual resources (as defined in Annex A) have previously been performed under both related and unrelated contracts, some by Canadian Forces members, and some are of new initiatives.

None of the sites are considered new DND facilities.

The estimated level of effort per resource can be found at Attachment 4.3 of the solicitation.

Question 004: In order to confirm manning levels and resources for this initiative, clarification of the levels of effort identified in Attachment 4.3 – Pricing Schedule on pages 97 to 99 of 100 for the 17 positions will need to be clarified for the following locations:

- 7 Telecom Sys Specialist for 720 days for the initial period of the contract and 240 days for each of the option periods
- 1 Telecom Sys Specialist to work at CFB Kingston, ON 720 days for the initial period of the contract and 240 days for each of the option periods
- 2 Telecom Sys Specialist to work at CFS Matsqui, BC 720 days for the initial period of the contract and 240 days for each of the option periods
- 1 Telecom Sys Specialist to work at CFS Riverbend, AB 720 days for the initial period of the contract and 240 days for each of the option periods
- 2 Telecom Sys Specialist to work at Point Petre, ON 720 days for the initial period of the contract and 240 days for each of the option periods
- 2 Telecom Sys Specialist to work at Newport Corners, NS 720 days for the initial period of the contract and 240 days for each of the option periods
- 2 Telecom Sys Specialist to work at CFB Trenton, ON 720 days for the initial period of the contract and 240 days for each of the option periods

Answer 004: In accordance with section 7.2 of the solicitation, work will be performed on an “as-and requested basis” using Task Authorizations which will identify the estimated level of effort of each assigned task at the time of issuance. At this time, the estimated level of effort for each resource category is 240 days per year (720 days in total for the initial 3 year contract and 240 days per each identified option period).
