Question: In Amendment 006: A 20fps minimum frame rate is specified for 'the camera'. Does this requirement apply to all cameras, including Thermal cameras?

Response: This requirement of 20fps applies to all camera except for Thermal Camera which is 9fps minimum.

Question: In Amendment 006: In response to the question on warning zones and No fly zones, you appear to state a >=400m low confidence recognition range and >=750m high confidence recognition range this appears to be opposite to ranges quoted in Appendix A 4.2.14 & Appendix A 4.2.15 with regard to High and low Fidelity classification. Could you clarify the difference or error if appropriate.

Response: My error sorry, A 4.2.14 and A4.2.15 are correct. >=400m is for high confidence detection range and >=750m is for low confidence detection range

Question: We respectfully requests at least another 1 to 2 week extension to the deadline.

Question: Would you be able to provide us with a contact name that is involved in managing the Alma Testing Site?

Response: This information will not be provided. As per the RFP, the top 3 lowest technically compliant offers meeting the mandatory technical criteria, Canada will request that the Offeror perform a Data Validation Test with a system of the type proposed for purchase to validate performance claims and compliance with the requirements before issuing the contract.

Question: The purpose of this email is to advise you that we are contemplating not bidding on this procurement due to the use of Spotter RF's technology in development of the recommended technical specifications of radar positioning in the six site reports. We perceive that the recommended positions of the radars as described in each site report as a potential violation of Article 1007 of NAFTA and therefore respectfully request your consideration that Spotter RF's technology be prohibited from being accepted as an acceptable solution on this procurement. If you could please respond on this comment that would greatly be appreciated.

Response: In accordance with NAFTA, Annex 1001.2b, General Notes, this requirement is not subject to NAFTA (see below). Further to this, the Notice of Proposed Procurement (NPP) has been amended to reflect the change.
