Parks Canada Agency (PCA) has obtained +/- 7,600 lineal feet of new unprimed cedar siding for use on this project. Siding to be primed as noted in specifications for new material. Contractor shall verify all quantities and condition of siding and shall provide sufficient quantity of additional siding to complete the project.

REPLACE WITH:

All siding must be provided by the Contractor and shall have sanded texture and shall be factory primed as noted in Specification Section 07 46 23, paragraph 2.1.2.

### 3. CORRECTION TO AMENDMENT 001

DELETE:
