The Solicitation Amendment is raised to provide additional information in regards to the packaging of the neck bands and provide photos to show the neck bands on rolls:

- Request for Proposal (RFP), Annex A, A1 Technical Requirement, Item 2:

Add: The neck bands must be packaged in rolls. Each roll of neckbands must have a quantity between 35 meters and 55 meters. Each roll must have a cardboard tube in the center of ½ inch to 1 inch in diameter. The rolls must be packed in cardboard boxes and then placed on pallets for delivery.

- RFP, page 15, Article 6.4.4. Packaging – Commercial:

Delete: The material must be delivered on pallets, wrapped in two plastic bags, and marked with:
