Amendment 004

This amendment is raised to:

- 1) Answer questions received from Industry.
- 2) Modify the quantity of required goods, the delivery periods and remove commissioning from the requirement. This includes modifications to several articles within the RFP, Schedule A - Basis of Payment, Schedule B – Schedule of Deliveries and the Statement of Work (SOW).
- 3) Provide clarification regarding the submission of Compliance Assessment Reports (CARs) as part of the Phased Bid Compliance Process (PBCP).

1. QUESTIONS AND ANSWERS

QUESTION 1:

In the tender EREP: Towable Tank - Floating Fabric Bladder (F7047-170069/A), it is required in the Technical Statement of Requirements 4.2.6.3 Coated Fabric Welding that “ Coated fabric seams must be permanently bonded by RF welding complete with top and bottom cap strips (double butt strap seam). Coated fabric joined by sewing or adhesives is prohibited.”

This RF welding requirement applies to PU or PVC coated fabrics (thermoplastics) but not to rubber coated fabrics.

However, our towable floating bladders are made from rubber coated fabric, and the fabric is assembled through a vulcanization process which is even more reliable than RF welding, but only applicable to rubber coated fabrics.

Can you tell us if our type of fabric (rubber coated) and assembly (vulcanization into an autoclave) are acceptable for this tender?

ANSWER 1:

No, requirements are as per the Technical Statement of Requirement (TSOR).

QUESTION 2:

ISO 14001:2015 is a more universal standard than ASTM. Please advise on ISO standard as acceptable for what we wish to propose?

ANSWER 2:

No, requirements are as per the Technical Statement of Requirement (TSOR).

QUESTION 3:

May we submit a bid in French?

ANSWER 3:

Yes, you may submit a bid in either of Canada’s official languages (French or English).

QUESTION 4:

I believe we have a PBN number. Can you confirm and/or advise how we can obtain this number?

QUESTION 5:

Delivery dates are listed as “requested” by March 31, 2021 (Delivery Period 1) and March 31, 2022 (Delivery Period 2).

We typically expect to see the delivery dates for required goods as “must be” or mandatory dates. Annex 2 to Part 3 of the solicitation section 6 advises that submitting dates themselves with the bid is mandatory - so while we will of course submit our best delivery dates, please confirm that these submitted dates themselves are only guidelines, and will not form part of any evaluation criteria?

ANSWER 5:

It is mandatory to submit delivery dates in Schedule B – Schedule of Deliveries, however the dates submitted are not being evaluated. Bidders are required to submit their best delivery date in Days after contract award and those dates will form part of the Contract.

QUESTION 6:

Can you confirm that Delivery Period 1 and 2 run concurrently? I.e. it is acceptable to offer delivery dates for Period 2 that are before March 31, 2021. Please also confirm the “Days after Contract” award indeed means number of days from initial contract award (and not resetting to 0 from the last day of delivery period 1)

ANSWER 6:

Schedule B is being amended, there is no longer a requirement for two (2) delivery periods. Days after contract award means number of days after initial contract award.

QUESTION 7:

Wanted to inquire about the Equipment Commissioning and how it ties into payment – Section 3.4 states the commissioning of goods must be completed prior to acceptance of goods. How do all the goods get accepted and therefore approved for payment?

We do see there is both first article and factory acceptance testing. If Canada approves a factory acceptance test report for each manufactured item, could it then be “approved” at factory for shipment and then once goods received by client at destination, Canada would then accept an invoice for processing (98% payment)? In this proposed scenario, we would foresee invoicing once per destination.

ANSWER 7:

Section 3.4 of the SOW (Equipment Commissioning) is being removed. There is no longer a requirement for Equipment Commissioning Training, an Equipment Commissioning Plan or Equipment Commissioning Instructor Manuals and therefore commissioning is not tied to payment.

The Contractor may submit a claim for payment after delivery and acceptance of the goods by Canada, as per General conditions 2003 (12 (2014-09-25)) and Articles 6.7.5.1 Multiple Payments – Subject to Holdback and 6.8 Invoicing Instructions.

2. MODIFY THE REQUEST FOR PROPOSAL AND STATEMENT OF WORK

At Article 3.1.5.4

3.1.5.4 Delivery Dates

While delivery of applicable items in Schedule A - Section 1 (Required Goods and Services) are requested to be delivered as soon as possible, the Bidder is required to propose their best delivery date in Schedule B.

At Article 4.1.3

Delete: Article 4.1.3 in its entirety

Insert: Article 4.1.3 as follows:

4.1.3 Financial Evaluation

Evaluated Price = A + B + C

A = Sum of the extended prices of items 1 – 5 (inclusive)

B = Sum of the extended prices of items 6 – 9 (inclusive)

C = Hourly rate identified by bidder for options and unscheduled work will be multiplied by 1000 hours*
* 1000 hours is used for evaluation purpose only and in no way represents commitment by Canada

Extended Price for EACH item in A is calculated as follows:

-Item #1 Quantity x Item #1 Firm Unit Price = Item #1 Extended Price

-This is repeated for items 2 – 5 inclusive.

Extended Price for EACH item in B is calculated as follows:

-Item #6 Quantity x Item #6 Firm Unit Price = Item #6 Extended Price

-This is repeated for items 7 – 9 inclusive.

Extended Price for Hourly Rate in C is calculated as follows:

- 1000 hours x Hourly Rate

3. CAR CLARIFICATION

As per section 4.1.1 of the RFP, this procurement is subject to the Phased Bid Compliance process and all bid submissions will be evaluated accordingly.

Canada will send a written notice (CAR) to each Bidder identifying any Eligible Mandatory Criteria that the Bid has failed to meet.

In the event that a Bidder's proposal has been identified as failing to meet any of the Eligible Mandatory Criteria, that Bidder shall have the period specified in the CAR (the "Remedy Period") to remedy the failure to meet any Eligible Mandatory Criterion identified in the CAR by providing to Canada in writing additional or different information or clarification in response to the CAR.

IMPORTANT INFORMATION TO NOTE

All responses to a CAR must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated in the CAR.

The following are the only methods acceptable for a Bidder to submit their responses to a CAR.

- 1- Mail or in-person to the PWGSC Bid Receiving Unit;
- 2- Facsimile to the number indicated in the CAR; or
- 3- The use of epost Connect.

If epost Connect will be used to submit a CAR response, Bidders are required to send an email the PWGSC Bid Receiving Unit (email address above), including the bid solicitation number, requesting to open an epost Connect conversation as early as possible. As it could take at least six business days to ensure a response, it is recommended to do this at least six business days prior to the solicitation closing date and time, or as soon as possible. If this action is not performed promptly it could impede the Bidder's ability to use epost Connect as a method of submitting their responses to the CAR.

Please note that the use of epost Connect only applies to CAR responses.

As per Article 2.2 Submission of Bids - Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated in the bid solicitation.
