The following is in response to inquiries received in relation to this solicitation. This amendment will form part of the contract documents.

Question 1

Q1a: The list of required services provided on page 69 and the detailed breakout of required services on pages 77-84 are not consistent with the requested project examples as stated in Section 3.2.3 (2)(a) on page 51 of the proposal PDF document, please confirm.

Q1b: Section 3.2.3 (2)(a) on page 51 of the proposal PDF document appears to suggest a project example for RS 4 is not required in the proponents proposal, please confirm.

A1. Please refer to solicitation amendment 002, #3.

Question 2

Q2. Items 3.2.6.1 and 3.2.8.1 indicate «Considerations will be given to Proponent's team members who are licensed in both provinces». Does this statement apply to ONLY one Senior Geotechnical Personnel and one Geotechnical Project Engineer or to each individual personnel in these subcategories?

A2. This statement applies to section 3.2.6.2 a) and 3.2.8.2 a) where it is asked to provide a maximum of two (2) c.v.'s of senior personnel and maximum of two (2) c.v.'s of project engineers respectively.

Question 3

Q3. Items 3.2.6.1 and 3.2.8.1 indicate «Considerations will be given to Proponent's team members who are licensed in both provinces». Please define how this statement will be evaluated using provided generic evaluation table in the RFSO.

A3. Sections 3.2.6 and 3.2.8 will be evaluated as a whole and not solely based on licensing in both provinces. However, for equivalent personnel submitted, more points (approximately 1 point) will be allowed to personnel licensed in both provinces.

Question 4

Q4. Will resumes of key personnel from subconsultants assigned to this project be considered in the evaluation of items 3.2.6.1 and 3.2.8.1 «Considerations will be given to Proponent's team members who are licensed in both provinces»?

A4. No.

Question 5

Q5a: The price form and Q&A indicates that the Senior and Intermediate personnel must be licensed professionals. We understand that this would include the Environmental Professional (EP) designation,

the Professional Agrologist (P.Ag.) designation and any other relevant professional designation (eg. P.Chem, P.Eng, P.Geo, etc.) correct? If not, please specify which professional licenses are acceptable.

Q5b. In Appendix B of the proposal PDF document, “intermediate personnel” are defined as “licensed as a professional having five (5) to eleven (11) years’...” Is the intent of this requirement such that proposed intermediate personnel must be licenced as a P.Eng or P.Geo, such that environmental scientists, biologists, industrial hygienists, etc., cannot fill the “intermediate personnel” category?

A6. Only licensure provided by Professional Engineering Associations or Professional Geoscientist Associations are acceptable for environmental personnel requirements.

Question 6

Q6: Please clarify how rated criteria 3.2.7 Environmental Project Personnel CVs and 3.2.8 Geotechnical Project Engineer CVs will be evaluated. Will more senior personnel CVs score higher? Are senior personnel CVs excluded since 4 senior CVs have been requested previously in 3.2.5 and 3.2.6? Are you looking for a mix of seniors, Intermediates and Juniors to get maximum points?

A6. In response to SRE section 3.2.7 Environmental Project Personnel Expertise and Experience and SRE section 3.2.8 Geotechnical Project Engineer Expertise and Experience, the proponent should present key personnel who will perform the tasks under the intermediate personnel classifications only.

Question 7

Q7. In Appendix B, the definition for Field Technician includes Junior Personnel with 0-4 years relevant environmental and/or geotechnical engineering experience. Can the Geotechnical Field Technician personnel CV (section 3.2.9 in the RFP document) include junior engineering personnel with 0-4 years relevant environmental and/or geotechnical engineering experience?

A7. Yes.
