ANNEX "A"

REQUIREMENT

The Contractor must supply, deliver and unload custom Evidence Storage Lockers to the Royal Canadian Mounted Police (RCMP), to be delivered to Red Deer, Alberta, in accordance with the requirements specifications, terms and conditions detailed herein.

The Evidence Storage Lockers must include the following specifications:

The evidence storage lockers must arrive fully assembled and be constructed in a fashion to ensure items placed within the storage locker can only be removed if the locking mechanism is disengaged. The lockers must be designed to ensure secure storage to prevent unauthorized handling and to maintain a secure chain of custody.

- A. Dimensions of 84 inches high by 36 inches wide by 24 inches deep.
- B. Constructed with 18 gauge cold rolled steel
- C. Epoxy powder coat finish.
- D. Lockers to be neutral colour such as tan, beige or grey. Colour to be selected upon Contract Award.
- E. 4" diameter vent connection on the top centre of the unit.
- F. Louvered vents on the bottom of the doors for fresh air intake
- G. Lock capability, either padlock or locking mechanism built into the door, one lock per cabinet. The RCMP will supply the padlocks.
- H. Four adjustable stainless steel shelves with adjustments in 1 inch increments. One of the adjustable shelves require a 12 inch wide and 6 ½ inch deep cut out on the left half of the front portion of the shelf.
- I. One fixed shelf with a 12 inch wide and 6 ½ inch deep cut out on the left half of the front portion of the shelf.
- J. Double door access
- K. All shelves are to be perforated to allow airflow
