### 1. Answers to bidders' questions.

**Question:**

According to the Annex B, Item 3.8.1.b – Transmission with 6 forward speed would be acceptable?

**Answer:**

Yes, it's acceptable.

Paragraph 3.8.1 (b) will be amended to read: The transmission *must* have at least six (6) forward speeds and one reverse speed.

**Question:**

According to the Page 56, item g, passenger seating, V: passenger seating with 900 mm nominal width would be acceptable?

**Answer:**

Yes, it's acceptable.

Paragraph 3.5 (g) v will be amended to read: Passenger seats *must* have width of at least 900 mm (35.43 inches);

**Question:**

According to the Page 56, item g, passenger seating, iii: is it possible to offer passenger seats without center armrest?

**Answer:**

Yes, it's acceptable

Paragraph 3.5 (g) iii will be amended to read: Passenger seats *must* be provided with stationary wall side armrests and pivoting aisle armrests.
