Amendment # 1 is issued to clarify queries from the site visit July 24, 2019.

Question # 1

Can we confirm that when work is being done in the AC boardroom and main 4th floor boardroom, that the contractor can have full access while they are completing the work and that no meetings will take place in those spaces while this is happening? Maybe for a 3 day period or so.

Answer#1

Confirm that this is possible, room will be blocked off for installation

Question # 2

In addition, can we keep the 4th floor boardroom shut to the main building employees and just open for the contractors and a few people involved in the project? This will allow the contractors to keep tools and equipment safely onsite for the duration of their work. Please note this will likely be for several weeks.

Answer#2

Confirm they can use boardroom 413 to keep tools and supplies in. Contractors are advised they are responsible for any damage in the room as this room is completed and has been signed of under the construction project by PSPC.

Question # 3

Can we verify that there will be parking available for work trucks etc. either in the main parking lot or along the building on the dock? Several of the contractors wondered about this and mentioned about how it would take them much longer to complete the work if they have to drop off their equipment, drive far away to park the truck or van, and walk back each time they need something from their work vehicle (equipment, tools, etc).

Answer#3

Yes confirm we will ensure there are spaces either in the parking lot or on the wharf side or in behind the building for contractors to use. This will be limited by CG ops on the wharf as a side note.

Question # 4

Can we make it possible for the successful contractor to book an elevator out for a period of time to move equipment? If we do that, we will hopefully avoid complaints about unavailability of the elevators

Answer#4

No issues with securing the freight elevator for use while construction is ongoing. Employees will have to wait for the 2nd elevator or use the stairs in the meantime.

Question # 5

Data closet AV rack fitment

Answer#5

The AV rack will fit in the data closet with the ideal orientation being with the AV rack side facing the door.
