4.1.2 Financial Evaluation

The price of the bid will be evaluated in Canadian dollars, Applicable Taxes excluded, Delivery Duty Paid destination, Canadian customs duties and excise taxes included.

Bids will be evaluated to determine the lowest price on an aggregate price basis for the items and quantities listed in the Technical portion of the bid.

There will be no bid rejected based on a modified layout or configuration if it can result in a better value for money for Canada.

QUESTIONS AND ANSWERS #1

Q1: Are there specific qualifications or certifications required in order to install the supports?

A1: No particular qualifications or certifications are required, however, the bidder should be knowledgeable and experienced with installing support hardware into asphalt.

Q2: One of the racks that is specified in this tender is a wheel well secure rack to cradle 1 tire. We have 2 bike suppliers and both of them do not carry a rack like this for the primary reason that it often causes the front wheel to bend if someone were to knock a bike over. It is undesirable with cyclists due to the "wheel bender" effect and if there are a number of them side by side, the chances of bikes being knocked over is very high as they are much less secure and sturdy than the Inverted U shaped racks

Are you set on having this rack as part of the bid or would you accept an alternate that is more secure? Either more inverted U or a different style of rack? If this is the rack needed – do you have a specific supplier in mind that makes the model you are looking for? I would like to see the specs.

A2 : The documents do define that we are looking for a wheel-well secure style rack, which is included in the APBP (Association of Pedestrian and Bicycle Professionals) best practice guide, and is not a wheel bender style rack. The wheel-well secure style racks have a support for the frame of the bike to prevent them from falling over. The wheel-well secure racks provide a higher capacity - in the space where 8 bikes can park with inverted u racks, 12 can fit with wheel-well secure, so changing this would impact the capacity of the enclosures.

Q3. The RFQ states that all metal is to have a galvanized finish. Can we add extra protection by adding our signature finish over top? It is formulated especially for creating a cleaner galvanized look and presentation and adding durability. We already provided this finish for bicycle racks purchased by OC Transpo, City of Ottawa, Government of Canada and many others in Ottawa and other cities. This finish can be provided in absolutely any colour.

A3. The requirement for a galvanized-finish is so it will match the finish of the existing enclosures. Bidders may provide special coatings but Canada is not prepared to spend more per unit beyond the current specifications.
