(A) Respond to questions regarding the RFP

Question #1:

Where will the Partnering Workshop and the Integrated Project Delivery Workshop be held?

Answer #1:

During Predesign period, combined Partnering and Integrated workshops will be held in YK. During design development, the workshops will occur in Ottawa.

Question #2:

Will these be separated workshops or be held concurrently?
