SOLICITATION AMENDMENT NO. 003

This amendment 002 is to answer questions and amend the RFP accordingly.

QUESTIONS AND ANSWERS:

Question 015: Regarding Rated Criteria R1 – Why is the telecom/network emphasis on CBSA, DND, RCMP etc. SSC was granted the Order In Council to deliver network and telecom services to the GC, so this does not align to government priorities.

Answer 015: This requirement is aligned with the Canada First Defence policy and the Government of Canada's priorities. It is not in scope of the work granted by Order in Council to SSC. These networks include some functions that are associated with weapon platforms and are used for the defence of Canada amongst other operational requirements. The other Government and Crown Corporations stated in the criteria also have requirements that are not in scope of the services provided by SSC.
