Q1. Are bidders free to use any manufacturer's part that meets the noted dimensions on the drawing?
The drawing does not identify a manufacturer of Part Number GH-40380.

Q2. Is the vinyl handle with coating required?

Answers from Technical Authority

A1. Yes, however the manufacturer's part will be treated as an Equivalent Product, subject to and must comply with the Bid Solicitation's Terms and Conditions as per Section 4.1.1.2 Equivalent Products – Bid and Section 6.18 Equivalency of Equipment and all bids submitted must include technical specifications.

Part Number GH-40380 is manufactured by Good Hand Inc. and can be used as a reference, as the drawing outlines the exact technical specifications required.

A2. The vinyl handle must be part of the completed latch assembly and requires coating as specified in the drawing to protect it from the elements and prolonged use.

All other terms and conditions remain the same.
