#### 2. Question and Answer:

#### Question 1:

Annex B states that the pricing is per person/per session for columns A and B, and the estimated number of sessions are included. However, the second column states 'estimated number of sessions per year' not 'estimated number of participants per session to base the totals on. Was the pricing suppose to be a per session rate, not a per person rate? Or are we suppose to base the pricing on the maximum numbers or participants allowed per session?

#### Answer 1:

Based on the minimum and maximum number of participants per course as stated in 4.0 of the Annex A – Statement of Work, bidders are requested to provide an all-inclusive firm rate pricing for columns A and B of the Annex B – Basis of Payment, as 'per participant/per session.

The column indicating the 'Estimated Number of Sessions per year' is for information and for evaluation purposes only.




