**Amendment 002 is generated to respond to questions raised after the release of the Solicitation.**

- Q1: When you say Steelite Alvo White China Plate (*or equivalent*), does equivalent mean, that any other brand with similar design and specifications is acceptable?
- A1: As two of the four messes already have Steelite Alvo brand dinnerware we require dinnerware that is interchangeable or combined with the current supply to accommodate larger events, therefore, the product must meet the Mandatory Technical Specifications identified in the RFP.
- Q2: Is the entire quantity expected to be shipped one time or are multiple deliveries accepted over a period of time?
- A2: Multiple deliveries are acceptable.
- Q3: There are some curves on the surface of Steelite Alvo China Dinnerware, must the substitute China Dinnerware have these curves as well?
- A3: No, it is not necessary.
- Q4: Is the smooth surface for the substitute China Dinnerware acceptable?
- A4: The smooth surface is acceptable.
- Q5: Can I include both Steelite and equivalent alternative in my bid submission?
- A5: Yes.
- Q6: Is it mandatory to complete the Mandatory Technical Requirements – Cross Reference sheet even if I am offering the exact part number required for Steelite Alvo China Dinnerware?
- A6: It is mandatory for all bidders to complete Annex E, Mandatory Technical Requirements – Cross Reference.
- Q7: Can you indicate if Item # 7 on page 14 of the RFP is referring to “covered sugar pot” or “covered sugar cup”?
- A7: Covered sugar pot.
