#### Questions and Answers

Q: Contact information for people who run and maintain Iron Creek Maintenance Camp, JJJ Gravel Pit and Km 713 Gravel Pit

A: Contact information will be provided to the contractor upon contract award.

Q: According to Section 02 61 00.07 "Contaminated Sites Onsite STF Operation 3.3.6 – Movement of treated soil to final treated stockpile area is located within 100 meters of the soil treated facility. But according to the Site Plan -JJJ Gravel Pit DWG No: 636200-1009 the distance from the STF 1,2,3,4 to Compliant soil stock pile is much greater than 100 meters.

A: For JJJ STF, movement of treated soil to final treated stockpile area is located within 600 meters of the soil treated facility.

Q: Do we require a wash station and an office facilities for each location in Iron Creek Maintenance Camp, JJJ Gravel Pit and Km 713 Gravel Pit?

A: Yes

Q: Where are the treated soils being relocated to for each of the sites?

A: For Iron Creek STF and Mile 713 STF, as per Division 02 61 00.07, Part 3.3.6. Following in-situ sampling and confirmation by Departmental Representative, move treated soil from Soil Treatment Facility to the final treated soil stockpile area located within 100 m of the Soil Treatment Facility as directed by the Departmental Representative. For JJJ STF, movement of treated soil to final treated stockpile area is located within 600 meters of the soil treated facility.

Q: For the treated soil relocation quantities found in the Price Form, are these firm quantities for how much treated soil will be relocated or might the quantities vary?

A: No anticipated changes to the quantities at this time.

Q: How many pieces of equipment are required at JJJ STF?

A: Refer to Division 02 61 00.07, Part 2.2.1 Add: For JJJ STF, minimum of two tillers to be one or more tractor and/ or excavator to achieve efficient aeration of each 400 mm lift.

Q: Although the soil quantities at each work site varies from one site to another the total hours allocated for tilling are equal for all three sites (420 hrs). Can you confirm the duration of tilling that is expected at each facility?

A: Duration will be as indicated in unit price table. Tilling duration may not be dependent on volume.

Q: Is there a duration of tilling per m2 of lift that is expected for this work scope for each STF?

A: Per Division 02 61 00.07, Part 3.3.3 Aerate Till the upper 400 mm of the contaminated soil within Soil Treatment Facility based on field observations by Departmental Representative. This process will be repeated for additional lifts as the upper layer is deemed treated by the Departmental Representative.

All other terms and conditions remain unchanged.
