**QUESTIONS AND ANSWERS:**

<b>Question 1</b>	In regards to solicitation mentioned above, we are requesting to kindly change the required distance between delivery location and authorized dealer to 150 miles (240 km) instead of 150 kilometres in reference to 3.5 Section IV: Additional information item (c)
<b>Answer 1</b>	<p>The only reference to 150 kms is contained in a document entitled Contract Demand Requirements produced by the Technical Authority to help assist the Contracting Authority with the development and publishing of the solicitation documents and does not use the word "MUST" as a criteria, ie the "after-sales" service provider MUST be within 150 kms of the destination location. Therefore, bidders will be permitted to identify in their submissions the actual distance between their "after-sales" service provider and the equipment destination location. When bids are evaluated, this distance will not be factored in as a determination in awarding contract or not.</p> <p>Also, bidders are to note the following:</p> <p>"If action to effect repairs under warranty cannot be initiated within 2 working days and completed within a reasonable time period, or if the Contractor has no repair facilities in immediate vicinity (within 150 kilometres) of the specified delivery destinations, Canada reserves the right to make the repairs and be reimbursed by the Contractor at the rate of \$103.91 per hour and the cost for replaced parts."</p> <p>This clause will be added to contract(s) awarded where the "after-sales" service provider is beyond the 150 kilometre distance guideline.</p>
