AMENDMENT #003

The intent of this amendment is to:

- revise answer A1 originally provided in Amendment #001
- answer other potential bidders' question
- revise some usages and details in Annex B-1 and
- remove any references to 5P300-190145/B and 5P300-190145/C.

AMENDMENT #001: Q1. We have question regarding the length of the timber. In the table at end of the specification, it is mentioned various length for some items. Would you please clarify this? Is it one foot length?

RESPONSE HAS BEEN REVISED TO: A1. The Unit price is per foot based on orders that vary between 10 feet and 40 feet. Annex B-1 has been revised.

Q2. Annex "A", 2. Mandatory Minimum Specifications,
2.2 states:

(b) All lumber supplied will have tight grain with no less than 8 growth rings per inch of thickness";

(c) All lumber under ten (10") inches in thickness is to:

- i. be "Boxed heart" cut "off the heart center" with minimal sapwood allowed; and*
- ii. the knots must be in accordance to the N.L.G.A. grading rule 130a*

2.6 states: *No wane will be accepted on any items.*

Would Parks Canada consider going to 6 rings (no wane), lite to no sap wood?

A2. The referenced mandatory minimum specifications cannot be changed. The reduction of the grading will have a significant impact on the life expectancy of the logs and reducing the number of rings will cost more in the long run, due to a higher frequency of replacement.

Q3. The tender for 3 years shows a closing date for 2021. Are we expected to quote all 3 years at the same time?

A3. Only one year of pricing is required and the period of the Standing Offer will be from date of issue to 31 July 2020. To avoid any confusion, the solicitation documents have been revised into 3 separate request for standing offers.
