AMENDMENT #001

The intent of this amendment is to answer potential bidders' questions.

Q1. In reference to Annex "A" there are 3 different destinations for requested items. Also in section 4.2.1 is mentioned only one bid with lowest price will be awarded and must be within 30km of CFB Trenton. Please clarify the price for all goods must be FOB Trenton and ship to Trenton only.

A1. The geographical limitation was for the technicians from 86 ASU to be able to go to the vendor to either have parts fabricated in emergencies like hydraulic lines or to match up single fittings. To have a vendor more than 30 km away would entail too much travel by the technicians to get 1 of parts.

The three locations would be referring to #5 Supply Depot in Montreal, #7 Supply Depot in Edmonton and to our location at 86 ASU Trenton. The Item Manager may choose to purchase items to be stocked for other RCAF wings for consumption again this could be specific fittings, seals or consumable parts. Hence the standard of three potential stocking locations.

Note: Annex "B" stipulates pricing is firm and all-inclusive in Canadian Currency, FOB Plant. Any delivery charges should they apply will be applied to the invoice as a separate line item.

Q2. Bidder: After reviewing the RISO it is understood that there are a range of different manufacturers on your tender. To correctly quote on this program, we would need to assess the needs with our product rep through XXX. Please let me know if it is an option for us to conduct an in-person survey of the products you are currently using and if it is open for us to quote a full new program.

A2. A complete survey and revamp of the hydraulic systems is not required. There are a range of manufacturer parts required for these systems and it is necessary to keep parts as close to OEM as possible. Any deviation requires approval to ensure that systems will operate according to original design parameters.

Items may be substituted as long as they pass the "fit form and function" requirement as described in Part 2, 2.5 Equivalent Products to ensure seamless attachment, without modification, to our current systems and operate the hydraulic systems as originally designed.
