### **AMENDMENT 003**

The purpose of Amendment 003 is to respond to Bidders questions.

**Question 1:**

In regards to MT5, the CP140 Aurora was introduced in 1980, and the P-3 Orion was introduced in 1962, as a result, we request that the cut-off of experience obtained to be changed to within the last one hundred and twenty (120) months to be more in line with the other mandatory requirements, and to allow a greater pool of qualified candidates.

**Response 1:**

The MT5 requirement is there to ensure we have included recent physical updates both to the aircraft and technologies applied to those aircraft. Therefore MT5 will not be changed.
