Solicitation Amendment No. 011

This solicitation is hereby amended to provide the following questions and answers:

Question 33:

Would the Crown confirm that no relevant project management experience of context and technical domains is required for this multi-year, multi-million dollar Contract for Defence Research and Development Canada and the sole criterion is to hold the PMP professional designation? If answer to prior question is yes, we are concerned that simply holding a PM designation and only having PM experience obtained from non HF R&D, non R&D projects adds an additional risk to the Crown that will impact the success of this R&D Contract. Furthermore, it should be noted that to hold PMBOK certification it is required that PMs must understand and use knowledge and skills from at least five areas of knowledge:

- The PM body of knowledge
- Application area knowledge, standards and regulations
- Understanding the project environment
- General management knowledge and skills
- Interpersonal skills

This contradicts any assertions that the PM requirement for the RFP should be limited to understand the PMI process independent of the task to its context. Thus, removing M2, the requirement for PM certification is inconsistent with the PMBoK certification requirement.

We strongly disagree with the premise stated in bidder question Q32, on which the amendment is based, to quote: "It is of significant concern that the stipulations surrounding the selection of the PM are more stringent than those surrounding the Scientific personnel." To review, the PM requirement was to be a full-time employee of the Bidder, hold a required designation and have five years similar experience in the last ten years. The senior human factors resources required for this solicitation are required to hold a required designation (degree), have the required years of relevant experience and furthermore required they have specific RCN project lead experience. There is nothing in the comparison of these two requirements to suggest that the PM requirement as it stood before this amendment was more stringent. In fact, with the removal of mandated PM criteria, it could be argued that PM requirements for this critical position are significantly diminished.

Answer 33:

The crown will not be revisiting this requirement as the Project Manager will have the necessary experience required by having a valid Project Management Certification, as specified in M1.

The PM resource is not required to have HF domain knowledge as this will be covered by the science resources which require significant knowledge in the HF domain

Question 34:

Would the Crown consider reinstating M2 so that relevance must be demonstrated by knowledge of the application area and a demonstrated understanding of the project environment?

Answer 34:

The Crown will not consider reinstating M2 as the criteria in M1 is deemed sufficient.
