Amend/revise the Standard Contract Documents as follows:

Contractor Questions

Question: I cannot locate the value of the float for insurance during transit.

Response: The value of the float for insurance purposes is \$1,000,000.00.

Question: Can you please confirm when the concrete float will be available for pickup?

Response: The float will be available for pickup on October 31, 2019.

Question: My electrical sub has noted that the electrical drawings indicate that there is work to be done in Hartley Bay. It is our understanding that the concrete float and SAR station are to be delivered to Steveston and that there is no work taking place in Hartley Bay itself. Please clarify.

Response: No work is to take place in Hartley Bay.

Electrical hookup to shore shown and any shore work as shown on E1.01 are not part of contract. Power and communications service from shore to termination point in building not part of this contract.

However, temporary power and communications hookup for the purpose of testing and commissioning is to be provided as per Spec section 01 11 55.
