We only sell equipment (CT, MRI, XRAY, Ultrasound) with a cost over \$100,000. Should we be submitting a bid for this current RFSO? Or would separate RFP's be issued for the type of equipment we sell?

Answer 44

This is not a mandatory Standing Offer for Medical Supplies and Equipment. Items may be purchased up to a maximum individual line item of \$25,000, as long as the \$40,000 individual requirement limitation is not exceeded (Refer to 7.10 Limitation of Call-ups).

If there is items that are not listed in the Product & Discount Offering, the buyer may purchase those items through other methods such as Local Purchase Order or a competitive solicitation, if applicable.

Question 45

At Part 1, under 1.2.1, it lists Dialysis Equipment and Supplies as part of the UNSPSC Sub-Categories that can be bid on, however the Product and Discount Template (Annex E) file does not contain a single item from this Sub-Category. Additionally, in Annex A, under 2 Allowable Goods, it states that only the goods already listed in Annex E are allowable through this standing offer. Please clarify the inclusion of Dialysis Equipment and Supplies in the list of allowable sub-categories, yet the exclusion of these items in Annex E.
