**RFP AMENDMENT 001 FOR FOR ACCOMMODATION SERVICES IN SUPPORT OF
OP NEON
FOR THE DEPARTMENT OF NATIONAL DEFENCE (DND)**

This RFP Amendment 001 is raised to change Part 2, Bidder Instructions, Part 4, Evaluation Procedures and Basis of Selection, and Annex "A", Statement of Work. Closing date of the bidding process is postponed to Wednesday August 28, 2019.

The RFP clauses' changes are the following:

1. At Part 2, Bidder Instructions:

- 1.1 At clause 2.5, Applicable Laws: Delete clause 2.5 in its entirety and replace it by the following:

2.5 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in British Columbia, Canada.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

2. At Part 4, Evaluation Procedures and Basis of Selection:

- 2.1 At clause 4.2, Basis of Selection: Delete clause 4.2 in its entirety and replace it by the following:

4.2 Basis of Selection

A bid must comply with all mandatory technical evaluation criteria of the bid solicitation to be declared responsive. The responsive offer with the lowest evaluated price (in Annex B, Basis of Payment) will be recommended for award of a Contract.

The final number of required guestrooms could vary based on Client final requirement.

Multiple contracts may be awarded. Contracts will be awarded to successful bidders in order of lowest evaluated price, until all requirements are fulfilled. The bidders must provide a minimum of twenty five (25) rooms.

3. At Annex "A", Statement of Work:

3.1 At clause 2.2, Technical Requirements:

- 3.1.1 Delete clause 2.2.1 in its entirety and replace it by the following:
2.2.1 Single occupancy rooms must be equipped with one (1) double bed or larger. However, rooms equipped with two (2) single beds (size of 190cm. X 120cm.) are acceptable. A sofa bed or cot will not be acceptable;

- 3.1.2 Delete clause 2.2.2 in its entirety and replace it by the following:
2.2.2 General room cleaning service must be performed on a daily basis or every two days. In any case, the hotel must clear the garbage bins on a daily basis. Minimum cleaning service standard requires bed made and fresh towels;
- 3.1.3 Delete clause 2.2.3 in its entirety and replace it by the following:
2.2.3 Fresh towel service, shampoo and soaps sufficient for the personnel in each room must be provided at every cleaning service;
- 3.2 **At clause 2.4, CAF responsibilities:**
- Delete clause 2.4.5 in its entirety and replace it by the following:
2.4.5 The CAF will give the Contractor seven (7) days' notice of when services requested may need to be cancelled. For less than seven (7) days' notice, CAF will pay a penalty of one night per cancelled room.

All other terms and conditions remain the same.
