2- Question and answer

Q1. Article 168 of Annex B.2 is identified as 'Other products'. Does it have to be discounted or left blank and it is the buyer who has to make bids made by suppliers?

A1. Article 168 of Annex B.2 must be considered in the same way as other products. If no percentage is indicated, the discount value will be considered "0". If a discount is offered in Article 168, the discount value will be firm for the duration of the Standing offer.

3- Modification of the request of standing offers

Page 7, Part 4.1.1 Financial Evaluation

Based on the largest number of firm discounts available on the list of 155 hardware products listed in Annex B - Basis of Payment.

All Offerors must offer a Firm Discount Rate (FDR) on a minimum of 40% of the **155 products (62 items) of hardware listed in Annex B, tab B.2 AND obtain a minimum average of 15% on the total firm discounts offered.** The FDRs must be based on the Retail Price List suggested by the manufacturer.

The ranking of winning offers will be in descending order, depending on the number of products with an FDR.

Example : For the Montreal metropolitan community

Average of total firm discounts granted	20%	12%	28%	20%	32%
Compliance of the offer	Not-compliant	Not-compliant	Compliant	Compliant	Compliant
Ranking of the offer	n/a	n/a	3 rd	1 st	2 nd

- Bidder A is not compliant because he only granted 55 products with FDR. A minimum of 62 products is required.
- Bidder B is not compliant because the average of total firm discounts granted is 12%. A minimum average of 15% is required.
- Bidders C, D, E meet the 2 conditions of compliance.
- The ranking is done in descending order of the number of products with FDR: D (120), E (105) and C (89).
- Winning offers are D and E because there is only a maximum of 2 Standing offers per region.

AND REPLACE WITH

Page 7, Part 4.1.1 Financial Evaluation

Based on the largest number of firm discounts available on the list of **168** hardware products listed in Annex B - Basis of Payment.

All Offerors must offer a Firm Discount Rate (FDR) on a minimum of **40% of the 168 products (67 items)** of hardware listed in Annex B, tab B.2 **AND obtain a minimum average of 15% on the total firm discounts offered.** The FDRs must be based on the Retail Price List suggested by the manufacturer.

The ranking of winning offers will be in descending order, depending on the number of products with an FDR.

Example: For the Montreal metropolitan community

- Bidder A is not compliant because he only granted 55 products with FDR. A minimum of **67 products** is required.
- Bidder B is not compliant because the average of total firm discounts granted is 12%. A minimum average of 15% is required.
- Bidders C, D, E meet the 2 conditions of compliance.
- The ranking is done in descending order of the number of products with FDR: D (120), E (105) and C (89).
- Winning offers are D and E because there is only a maximum of 2 Standing offers per region.

Bidders must provide a certification letter indicating they are authorized distributors/dealer on at least **40% of the 126 trademarks (51) on Annex B of the Excel file. Annex B must be completed and signed prior the issuance of the Standing Offer.**

Bidders must provide a certification letter indicating they are authorized distributors/dealer on at least **40% of the 117 trademarks (47) on Annex B of the Excel file. Annex B must be completed and signed prior the issuance of the Standing Offer.**
