AMENDMENT 007

This Request for Standing Offer (RFSO) amendment (**007**) is raised to provide clarifications sought by Industry.

1. Questions and Answers:

Question 21: Industry is asking if another version of Annex F – Microsoft Excel® Workbook will be uploaded on the BuyandSell site.

Answer 21: No new version will be uploaded in BuyandSell. If any line item(s) need to be deleted from now to closing, Canada will put a strikethrough for that line item.

Question 22: Some of Industry is concerned that two OEMs will not provide any quotes for many of the line items on the RFSO.

Answer 22: The two OEMs have been contacted and have confirmed that there are more than one source capable of providing an offer to Canada. All line items presently in this RFSO and those in Amendment 006 (line items identified by “Canada is reviewing”) will remain part of the RFSO requirement.

Canada will not eliminate any line items from the RFSO unless the line item is only available from one source such as an OEM who certifies it has all Intellectual Property Rights.

Question 23: Industry has requested an extension for this RFSO to October 18th, 2019.

Answer 23: Canada will not extend the RFSO's closing date and the closing date will remain September 13, 2019, 14:00 Eastern Daylight Time (EDT).

Question 24: Industry has requested that the procurement strategy change to 60% for filled line items and winning line items to 15%.

Answer 24: Canada will not change the procurement strategy and will leave the ratio to 70% (filled line items) and 20% best priced line items.
