This amendment has been raised to answer the following questions:

Q1: Please confirm that the required date of installation of the N2 tank and vaporizer would be approximately 3 months from the date of award, but the date itself is flexible with both parties needing to be in agreement with the date and schedule, as discussed during the site meeting.

A1: The current standing offer ends Oct. 31, so the switch would need to be complete by then. The switch would need to be scheduled with the old vendor, the new vendor, and Canmet to minimize supply disruption.

Q2: Please confirm that the flexible hoses, actuated valves, etc that are associated with the 'liquid supply' and 'vapor return' lines to the cryogenic N2 pump are owned by NRCan and as such will remain with the pump for reconnecting to the new tank, as discussed during the site meeting.

A2: That is correct.

Q3: Please confirm that the liquid N2 manifold used for filling liquid dewars (located at the front on the tank with valves, a flex-hose, and phase separator) is owned by NRCan and as such will remain at the site for reconnecting to the new tank, as discussed during the site meeting.

A3: That is correct.

Q4: Please confirm that there is no pressure regulation equipment or low temperature pipeline protection required to be supplied as part of the scope of work, as discussed during the site meeting. Note that there is currently no pressure regulation equipment downstream of the ambient vaporizer, and there is no low temperature pipeline protection downstream of the ambient vaporizer, so we would be maintaining what is at the site currently.

A4: That is correct.

Q5: Please confirm that backup N2 is only required for the low pressure gaseous N2 supply.

A5: That is correct.

Q6: The current requirement in the RFSO is to supply a 6000 gallon tank, with the site using approximately 96,000 m3 per year. Please advise if a 3000 gallon tank is acceptable? There will be more deliveries required, but Praxair will be supplying N2 pricing (per the RFSO) that is FOB NRCan, Devon AB, so there will be no additional charge(s) for increased delivery frequency.

A6: The preference is to maintain the current size.

All other terms and conditions remain the same.
