3) Response to bidder questions (Q&A):

Question 40: In both Annex B1-Appendix I and Annex B2-Appendix I for the non mandatory evaluation, the average PEB price calculation which carries into Appendix J for the Overall Evaluated Price seems to be skewed in favour of bidding the smallest amount of areas to get the lowest possible average PEB price. If a bidder only bids a single non-mandatory area in Annex B1 (which is the minimum requirement), the bidder will get the financial benefit of having their average PEB price reduced to 1/106. (1/92 for Annex B2). In order to represent the real average PEB price in appendix I, the bidder should be instructed to adjust the number of non-mandatory zones (primary + secondary) to be equal to the number of areas filled out in that section. If a bidder only bids on 10 non-mandatory zones in Annex B1, shouldn't the 106 in Appendix I be changed to 10? Note this applies for both the Initial period of 3 years as well as the 3 optional periods of 1 year. Please provide clear instructions to the bidder.

Answer 40: Annex B1 and Annex B2 have been updated to clarify how the tables should be populated.

Question 41: In consideration of the significant large level of effort to complete this bid response we request a 4 week extension to the current closing date of September 13, 2019 to Oct. 11, 2019.

Answer 41: The closing date of September 13th, 2019 still stands.
