1) Do you want 'Fresh' bread only or can we offer frozen?

Answer: Fresh bread only, Fresh being defined as All fresh items must arrive in good order with a best before date of a minimum of 7 days to expiry at time of delivery (Please refer to Annex "A", Requirement, , line item 2.3.2. of the solicitation document).

2) Refer to Annex "B", Food List and Basis of Payment, excel spreadsheet, LINES# 25-28 Tortilla Products. Tortilla Flour is almost never delivered fresh. Will you accept Frozen?

Answer: Willing to accept fresh or frozen products for the Tortilla line items # 25-28 inclusive in Annex "B", Food List and Basis of Payment. – Refer to 'Rebid Period 2' - Tortilla lines are now lines 25-28.

3) Delivery schedule, how often will they need delivery?

Answer: Minimum 2 days and maximum 5 days per week delivery, with specific delivery time of 0730-1200 hrs.

4) Will there be a Minimum order per Drop since this is just Bread tender?

Answer: We would prefer to not have a minimum order per drop.
